





5. Opening and closing the Device



- Always wear gloves or keep your hands dry while handling the PCB
- Do not touch the circuitry part of the PCB with bare hands
- Be careful not to break the button slots when de-attaching the PCB

For reset or replacing the batteries, opening of the enclosure is needed.







For opening the enclosure please follow the steps described below:

- 1. Unscrew the six screws on the bottom of the enclosure as shown in Fig 5.1
- 2. Gently separate the top and bottom case
- 3. On the PCB, replace the batteries or reset the device as explained in section 9 (Resetting the Device) or section 6 (Insertion & Replacement of Batteries)
- 4. Gently close the top and bottom of the enclosure together. Connecting wires must go across the enclosure as shown in Fig. 5.2. Tighten all the six screws

6. Insertion & Replacement of Batteries



- Open the device for replacing the batteries
- Always wear gloves or keep your hands dry while handling the PCB
- Do not touch the circuitry part of the PCB with bare hands
- Do not use sharp objects to remove the batteries

For replacing the battery please follow the steps described below:

- 1. Open the device (for details please refer to section 5 "Opening and Closing the Device")
- 2. The PCB is attached to the bottom of the case. To insert the batteries, **lift up two white battery caps** from battery holders of PCB , as shown in fig 6.1
- 3. White Battery Caps are provided to secure batteries in the battery holders to avoid battery pop-out and disconnection.
- 4. Insert 2 AA-Alkaline Batteries and make sure the positive (+) and negative (-) ends of batteries are facing in the correct terminals
- 5. After insertion of Batteries, cover the battery holders by using **white battery caps** as shown in fig 6.2
- 6. Once the batteries are inserted, close the top & bottom cases of enclosure as described in the instructions in section 5 "Opening and Closing the Device"
- 7. To replace the batteries: follow step 1 and 2 of section 6 "Insertion & Replacement of Batteries". Hold the LoRa PCB and carefully and remove the batteries from the holders and follow step 5, 6 and 7 of Section 6 for "Insertion & Replacement of Batteries".

The replacement of the batteries will trigger the device to register to the LoRaWAN network. Upon successful registration, the device will trigger 3 short beeps (chirps) in rapid succession. This implies that the device is activated in a LoRa network successfully and will send heartbeats and alarms via LoRa.

Note: If rejoining of the device fails, one can manually reset the device as described in section 9 "Resetting the Device"



7. Activation of the Device

i	 Device must be provisioned in the LoRa network before activation, as otherwise it will continuously send join requests towards the network, which may result in quicker battery discharge Remove Battery insulating Pull Tags for activation Device is for indoor application only

The device will automatically try to register to a LoRaWAN network upon insertion or replacement of batteries. Upon successful registration to the network, the device will trigger 3 short beeps (chirps) in rapid succession. This implies that the device is activated in a LoRa network and will send heartbeats and alarms via LoRa.

If the button is pressed, it raises a buzzer for a few seconds and the LED starts flashing. The device sends an alarm message to the LoRa network.

Using the 3 different buttons, different services can be notified. The payload of the LoRa message indicates which button was pressed and, if the Mutelcor Backend is used, different Dashboards can be triggered depending on the button pressed.

Every time a button is pressed, the following happens by default:

- The buzzer sounds for 30 seconds. The sound toggles every 0.25 seconds
- The LED starts blinking for 30 seconds. The flash toggles every 0.25 seconds
- An Alarm message is sent via LoRa, followed by 2 retries to ensure successful transmission of the Alarm. Each retry is sent after 10 seconds and at a different frequency channel

QR code sticker: All devices are QR-Ready. If requested, we can activate this feature to allow reading the current battery status by simply scanning a QR code. To activate the service, please contact your local distributor or Mutelcor GmbH at support@mutelcor.com

Note: If the buzzer in the device continuously gives a beep every 8-seconds, then there is a software error. When this happens the device must be returned for repair. Please immediately contact your reseller or Mutelcor GmbH at support@mutelcor.com

8. Mounting of Device



The device should be mounted on clean and non flammable solid surface

To ensure best product performance and prevent malfunctioning, avoid the following :

- Areas that are susceptible to vibration
- Areas near the high-voltage cables
- Near heating appliances and hot surfaces

Device Mounting can be done by following two options :

Option A : Paste the device directly with the provided **3M double-sided Tape** on the back of the device as shown in Fig 8.1 below

Option B : Use of Transparent PC (Polycarbonate) **Mounting Plate**:

Follow the instructions given in the document "Mounting Plate MTC-SCB" sent separately by email.

9. Resetting the Device



- Open the device for resetting
- Always wear gloves or keep your hands dry while handling the PCB
- Do not touch the circuitry part of the PCB with bare hands
- Do not use sharp objects to press the reset button

Resetting the device may be needed, e.g. to re-register the device into the LoRa network. For resetting please follow the steps described below.

- 1. Open the device. For details please refer to section 5 "Opening and Closing the Device"
- 2. Position and hold the PCB as shown in Fig 9.1
- 3. **Ensure** 2 AA-Alkaline Batteries are inserted in the battery holders
- 4. On the PCB, carefully observe a small reset button as shown in Fig 9.1
- 5. Press (do not hold) the button shortly for a second

The reset will trigger the device to re-register to a LoRaWAN network. Upon successful registration, the device will trigger 3 short beeps (chirps) in rapid succession. This implies that the device is activated in a LoRa network and will send heartbeats and alarms via LoRa.


